Tring Park Mansion House

We are hoping to arrange a private visit to Tring Park in late July 2018. Tring Park was built to a design of Sir Christopher Wren in 1685 and was visited several times by Charles II. It is now a School for the Performing Arts.

This should be a fascinating visit from a historical perspective but will also give us a chance to see behind the scenes of the theatre school.

<u>Planning</u>

- 1) Orchard Farm is a site of some 12 acres just beyond the entrance to Ladymead Farm and immediately to the south of the Blackgrove Road (the road which extends from the Strand eastwards to the cross-roads). The owner has already sold off approximately one third of the site for equestrian use and is now offering the rest of the site for sale. This is after having constructed an 88m long access track across this ancient ridge and furrow land and erected two large, skeletal, portal frames across the views of a part of Quainton, which has been designated as an Area of Attractive Landscape. It would appear that Permitted Development rules have been ignored and we trust that enforcement will be effective
 - 2) North End Nursery Laxton Properties have withdrawn two proposals for the development of this site but we are told that a third may soon be submitted.
 - 3) <u>Trail Flatt farm</u> It is understood that the enforcement procedure is progressing albeit slowly and we still await a proper conclusion to this long drawn-out affair.
 - 4) <u>Swan and Castle site</u> The application to build two new houses beside the Swan and Castle is still undetermined but permission has now been granted for the change of use of the Swan and Castle building itself to a dwelling house.
 - 5) <u>Land behind 151 Station Road</u> The application to build 80 houses on this site was refused, and so has a subsequent proposal to reduce the number of house to 40
 - 6) <u>Ladymead Farm</u> A further application for conversion of a farm building to residential use has been received while a decision on the further development of the industrial units is awaited.
 - 7) <u>Land between Seechfield and 62 Station Road</u> A decision is still awaited on the application to erect 13 houses on this site.
 - 8) <u>Brudenell House</u> amended plans in respect of repairs, alterations and conversion of the Coach House to residential use have been submitted and a decision is awaited.
 - 9) <u>24 Caultly Close extension</u>, <u>16 Church Street Dormer</u>, <u>3 Church Street extension</u> all awaiting decision
 - 10) <u>2 Church, new windows, Oak Tree Farm new agricultural building</u> both approved

11) <u>Harpers Ground Doddershall, new farm house</u> – a decision on amended plans is awaited
